### LETTER FROM THE PRESIDENT

This year's Annual Report highlights some great wins, despite business conditions that proved to be complicating—like sustained high interest rates and anticipated (but unknown) outputs of the national and state elections. As you will discover here, it was a banner year for CREDC results!

Our business development team achieved nine recruitment and expansion wins, resulting in \$338 million in capital investment, 445 new and retained jobs, and the subscription of 343,506 square feet of mostly industrial employment space. From announcing \$300,000 in SRF awards to

Analog Devices to advancing site variables for the go-live of Summit Truck Body in Ridgefield, our 2024 business successes underline that Clark County, WA, is a great place to locate and grow a business. Vigor Industrial's expanded \$1 billion contract to scale up manufacturing of MSV-Light landing crafts is a compound CREDC project success, yielding the dividend of 180 new jobs and injecting an estimated \$48 million into our local economy.

These wins for the community are achievable only through consistent CREDC investor support. Thank you to CREDC's annual and multi-year investors for







# ACCELERATOR PROGRAM

CREDC is proud to host the Washington APEX Accelerator here in Clark County. APEX provides assistance to small businesses wishing to sell to federal, state, and local government.

- In 2024, APEX at CREDC provided personalized advising to 153 new clients and conducted 105 follow-up sessions with established businesses, totaling 312 hours of dedicated guidance.
- Clients served by APEX in SW Washington secured 462 government contract awards, collectively valued at \$24,077,102.25.
- APEX hosted 19 events, attracting 641 attendees.

### **NEW WAYS TO GROW OUR MARKET**

The federal government spends between \$900 million and \$1.5 billion annually across Oregon and Southwest Washington—but Clark County's bounty rings in at less than six percent most years.

With CREDC competing for and gaining the host seat for the Department of Defense-sponsored APEX program in 2023, companies county-wide now enjoy free workshops, networking, and one-to-one guidance on responsibly bidding and winning government contracts—federal, state, and local—as well as post award support.
